\$1,000 Breeding fee: live cover - payable upon signing this contract, and/or before first cover of mare.

\$ 200 Additional fee: for shipped (fresh, cooled) semen - payable upon signing this contract and/ or before first shipment.

\$12.00 per day for board of mare before departure.

\$15.00 per day for board of mare with foal before departure.

All accounts for board bills and any veterinary expenditures made on behalf of the mare and/or foal will be settled by the mare owner upon receipt of a duly rendered statement.

The mare and/or foal will not be released until all accounts are settled to the satisfaction of Klaus Biesenthal.

The mare shall be healthy and in sound breeding condition as evidenced by a recent culture.

Klaus Biesenthal will exercise judgment in the care and supervision of the mare and/or foal, but will not be held responsible for any accident, illness, injury or death to either. Likewise the mare owner shall not be held responsible for any accident, injury, or death to the stallion, or other equines on Klaus Biesenthal's property.

It is understood that the breeding fee is for a live foal that stands and nurses within 24 hours of birth. The live foal guarantee applies only if Klaus Biesenthal is properly notified by a statement from a licensed veterinarian that the mare did not deliver a live foal, whether the mare in question absorbed, aborted, or the foal did not stand and nurse within 24 hours of birth.

If the mare proves to be barren, does not produce a live foal, or is sold before the first cover, the mare will be entitled to return privileges for the same mare, or may sell the contract to another party, or substitute another mare. But be aware that this applies for only 3 years upon first signing of this contract, then any and/or all fees paid by the mare owner shall be forfeited and this contract is thereby cancelled, becoming null and void.

It is agreed that should the stallion **MAGNUM** expire, be sold by the owner, or becomes unfit for services before settling the contracted mare, then this contract becomes null and void and the full breeding fees shall be refunded to the mare owner.

Klaus Biesenthal agrees to settle the contracted mare with **MAGNUM** by either live cover, artificial insemination, or by shipped semen.

IF FOR ANY REASON the contracted mare does not become pregnant, the mare owner will have no cause to hold Klaus Biesenthal responsible, with the exception of term #9.

In the instance of shipped semen these terms will apply:

a) Full service fee payable before first shipment.

b) Klaus Biesenthal will ship semen in a container of his choice.

c) Klaus Biesenthal will ship semen by air cargo only, or the air transport of his choice.

d) Shipped semen containers must be returned **IMMEDIATELY** to Klaus Biesenthal by either UPS or Federal Express, not by registered mail.

e) Shipped semen containers that are not returned within five days from the original shipping date will incur a fee \$20.00 for each day until the container is returned.

No breeding certificate will be issued to the mare owner before all fees owed to Klaus Biesenthal have been paid.

Under no circumstances will any breeding fees or accrued fees be returned to the mare owner for any reason, with the on i exception being term # 9 of this contract.

When Klaus Biesenthal signs this contract it will then become a binding contract for both parties, subject to the terms and conditions specified and stated.
